

Official Rules

Eligibility dates: July 7, 2017 - July 17, 2017

Eligibility

NO PURCHASE NECESSARY. Open only to individuals who are legal U.S. residents and 18 years of age or older, and members of Common Ground Healthcare Cooperative at time of entry. Void where prohibited by law. Employees and family members of Common Ground Healthcare Cooperative (the "Sponsor"), and their respective subsidiaries, advertising and promotion agencies and the immediate family members and/or those living in the same household of each are not eligible for this promotion. All federal, state and local laws and regulations apply.

How to Enter

Fill out the photo submission form on the Common Ground Healthcare Cooperative website (www.CommonGroundHealthcare.org/PhotoContest) or email your photos directly to Photos@CommonGroundHealthcare.org. Photos must be received by us on or before July 17, 2017. Each photo submitted is worth one entry into a drawing. Entrants can submit up to five photos between July 7, 2017 and July 17, 2017. Entrants may enter to win the prize as set forth below. Incomplete entries are void.

The Sponsor is not responsible for lost entries, interrupted or unavailable network servers or other failed telephone or computer connections and/or transmissions, miscommunications, technical failures, jumbled, scrambled or misdirected transmissions, or other errors of any kind whether human, mechanical or electronic that may relate to the website. - Each entry must be submitted to Photos@CommonGroundHealthcare.org. By submitting your photos, you agree to the official submission guidelines.
- Do not place a watermark on photo submissions.
- There is a limit of five photo submissions between July 7 and July 17. Each photo submitted is worth one entry into the random drawing.
- Participants must be 18 years or older.

- You are responsible for obtaining the necessary releases from every identifiable person depicted in your photo (for minors, releases from their parents or legal guardians are required), and you must be able to provide copies of those releases to Common Ground Healthcare Cooperative at the time of photo entry.
- You represent and warrant that the photo submission is your original work, that your submission does not violate any agreement between you and a third party, and your photo shall not infringe upon or violate any law, agreement, or other rights of any kind, of any third party, without limitation, rights affecting copyright, patent, trademark, unfair competition, contract, defamation, privacy or publicity.
- Common Ground Healthcare Cooperative reserves the right to disallow submissions that depict brand logos or other intellectual property, whether on signs or posters or in other forms, or that in its judgment are harmful to the public order or violate standards of decency.
