Electronic Claims Submission and HIPAA Eligibility and Claims Transactions

CGHC has partnered with Smart Data Solutions (SDS) clearinghouse to process all of our EDI claims submissions and receive and respond to all HIPAA 270/271 Eligibility and 276/277 Claims transactions. Providers interested in submitting claims electronically or sending and receiving the HIPAA compliant transactions should contact Smart Data Solutions at 855-297-4436 or by registering on their website www.sdata.us/edi-clearinghouse and clicking Sign up for Provider Registration Assistance.
